

ADVERTISEMENT FOR BIDS

Sealed bids for the construction of the Bartlett Hall Envelope Repairs a project at the University of Northern Iowa will be received electronically through www.bidexpress.com by the Iowa Board of Regents at the Office of Finance and Operations, 2401 Wisconsin Street, Lang Hall Room 122, University of Northern Iowa, Cedar Falls, Iowa 50614-0003 until 2:00 p.m. local Iowa time, on December 18, 2025, and will then be publicly opened and read aloud through a Zoom Meeting. The project consists of but is not limited to: selective brick removal and replacement to facilitate removal and replacement of degraded lintels. New lintel installation includes steel angle lintel, through wall stainless steel flashing, weeps and installation of new thru wall weeps. New lintels to be field painted along with select existing lintels to remain. Additional work includes selective repointing of brick masonry, removal and replacement of sealant joints at portions of the water table, concrete stoop cap repairs, sealing perimeter of concrete walks to walls and replacement of one concrete stoop.

Bids will be received for a stipulated sum contract.

Iowa Construction Sales Tax Exemption Certificates will be provided on this project.

Each bid shall be submitted electronically through the documents provided at www.bidexpress.com with an uploaded copy of the bid security as set forth in the Instructions to Bidders.

Bid security shall be agreed upon as the measure of liquidated damages which Owner will sustain by failure, neglect or refusal of bidder to deliver a signed contract stipulating performance of the work in unqualified compliance with Contract Documents or furnish the required 100% Contract Performance and Payment Bond within ten (10) days after receipt of Notice of Award.

No bid may be withdrawn for a period of forty-five (45) calendar days after the date of opening.

The Iowa Board of Regents seeks to provide opportunities for Targeted Small Businesses in accordance with the provisions of Chapter 73 of the Code of Iowa. This project has a participation goal for certified Targeted Small Businesses. The participation goal of 10% is specified in the Special Conditions.

By virtue of statutory authority, a preference will be given to products and provisions grown and coal produced within the State of Iowa.

The Iowa Board of Regents reserves the right to reject any and all bids, to waive irregularities and to accept that bid which is deemed in the best interest of the Owner.
