10 00 00 SPECIALTIES

10 10 00 – VISUAL DISPLAY BOARDS / INFORMATION SPECIALTIES

- A. Chalkboards/Markerboards
 - 1. Natural slate or porcelain-finished steel may be used for chalkboards. Use porcelain-finished steel when computers are present.
 - 2. Aluminum trim with map clips at top and tray shelf at bottom shall be provided with each chalkboard or marker board.
 - 3. Recommended manufacturer Claridge.
 - 4. Whiteboard wall covering is preferred. Whiteboard paint is not allowed.
 - 5. Glass markerboards may be used upon receiving owner's approval.
- B. Tackboards
 - 1. These should be of a type to withstand frequent changes of mounted material.
 - 2. When used in corridors or special areas, prefer a vinyl finish tack surface and glass enclosed.
 - 3. Recommended manufacturer Claridge. Confirm finish with Owner.

10 21 00 - TOILET PARTITIONS, COMPARTMENTS AND CUBICLES

- A. General
 - 1. Whenever possible, stall and urinal dividers shall be ceiling or wall hung, but floor support shall be included as needed for rigidity and long term lifespan. Obtain Owner's approval for installation type.
 - 2. Stainless steel and plastic laminate are not approved. Use solid composite HDPE or phenolic material partitions.
 - 3. Toilet compartments shall include doors with gravity closing hinges and coat hook.
 - 4. Provide "no sight line" partitions and doors specifically in the Department of Residence restrooms.

10 28 00 - TOILET, BATH AND LAUNDRY ACCESSORIES

A. General

- 1. Jumbo roll paper towel dispensers and toilet tissue dispensers will be provided by the Owner. Installation by Constructor.
- 2. The toilet tissue dispenser located in regular toilet stalls is to be Kimberly Clarke Twin Jumbo in Black (SKU-KCC09551) and the toilet tissue dispenser located in ADA compliant stalls is to be Tork Elevation T2 Mini Twin in Black (SKU-5555290). Toilet tissue dispensers are to be provided by the owner and installed by the contractor. Coordinate the location of the toilet tissue dispensers in ADA restrooms with the Owner's Representative and ADA guidelines.
 - a) Design Professional to provide specific locations on interior elevations for toilet paper dispensers. This includes both ADA and standard toilet stalls.
- 2. Electric hand dryers are preferred. Dyson Airblade V is preferred. Use the Dyson Airblade V hand dryer on all Department of Residence projects.
- 3. Integral bookshelf and hookstrip shall be provided in all public Toilets.
- 4. Recessed waste receptacles are not permitted. Free standing waste receptacles shall be provided by Owner.
 - a) Design Professional to provide location for waste receptacle in restroom. Coordinate with Owner for receptacle type.
- 5. Soap dispensers shall be provided by the Owner. Installation by Constructor.
- 6. Mirrors shall be ¼" thick, clear, heat strengthened, glass with full silver coating, copper coating, and organic coating, polished edges, and stainless steel J-channel trim.
- 7. Sanitary napkin disposal boxes will be Rubbermaid, white plastic or equivalent provided by the Owner. Installation by Constructor.
- 8. Chrome accessories are preferred.
- 9. Baby changing station to be Koala Kare, KB200. KB300, preferred color is grey or owner approved equivalent.

10 44 00 – FIRE PROTECTION SPECIALTIES

- A. General
 - 1. Fire extinguisher cabinets to be semi-recessed installation with vertical vision panel on door and rolled edge trim.

2. Fire extinguishers to be Sentry, General, or Badger. Clean Guard fire extinguishers may be used in large computer areas. Constructor to furnish and install extinguishers.

10 51 00 - LOCKERS

- A. General Recommendations
 - 1. Type style and size shall be specified.
 - 2. Provide a concrete base for lockers.
 - 3. Provide lockers with exhaust air ductwork hook-up for all lockers used within physical education or athletic locker rooms.
